Also, we fully agree and confirm the facts expressed on October 1, 2025 by the Head of the Specialized Anti-Corruption Prosecutor's Office, Oleksandr Kymenko, who truthfully accused the Ukrainian authorities of lacking the will to fight top corruption – <a href="https://ua.news/ua/ukraine/kerivnik-sap-zvinuvativ-vladu-u-vidsutnosti-voli-borotisia-z-topkoruptsiieiu">https://ua.news/ua/ukraine/kerivnik-sap-zvinuvativ-vladu-u-vidsutnosti-voli-borotisia-z-topkoruptsiieiu</a>.

According to him, we as a human rights organization fully confirm what was said, that the Ukrainian authorities demonstrate political will to fight domestic corruption, but do not show the same desire or will to overcome top corruption among the highest state officials. He means the top leaders of the state of Ukraine, who are very close to President Volodymyr Zelensky!

Therefore, recent events have forced us to finally break our silence, despite direct threats against our team and pressure from the Security Service of Ukraine (after recent appeals to you by international partners and the international community), especially against the former prosecutor of the Kyiv City Prosecutor's Office and honorary chairman of our organization, 51.2e

On September 5, 2025, in the city of Sumy, well-known journalist Oleksandr Takhtay, famous for his investigations into corruption in the construction of fortifications for the Armed Forces of Ukraine, was found dead (shot) - <a href="https://suspilne.media/sumy/1108518-na-sumsini-pomer-zurnalist-oleksandr-tahtaj/">https://suspilne.media/sumy/1108518-na-sumsini-pomer-zurnalist-oleksandr-tahtaj/</a>.

After systematically publishing articles about government corruption, he began receiving threats. In August, someone fired an unknown weapon at the window of Takhtay's dacha, and a smoke grenade was found in his apartment. The law enforcement agencies he contacted on the eve of his murder did nothing!

Also, the news that the National Anti-Corruption Bureau of Ukraine had launched an investigation into possible corruption abuses by the heads of the Poltava Regional Military Administration during the construction of fortifications caused a great public outcry - <a href="https://suspilne.media/amp/poltava/1106562-nabu-rozpocalo-rozsliduvanna-sodo-rozkradanna-kostiv-na-fortifikaciah-u-poltavskij-na-fortifikaciah-u-poltavski

This was reported by People's Deputy <sup>5.1.2e</sup> who published the NABU's official response to his appeal.

As is known, the investigation revealed that in 2024, the Poltava Regional Military Administration spent UAH 372 million on the construction of fortifications in Donetsk Oblast, but at least UAH 200 million of these funds disappeared due to schemes involving "front" companies, inflated prices, and fictitious contracts. Previously, materials related to this case were being investigated by the Economic Security Bureau in Poltava region and the Department of Strategic Investigations.

According to the investigation, at that time, the Poltava Regional State Administration was headed by <sup>5.1.2e</sup> who currently heads the State Financial Monitoring Service. His deputies were also not punished; on the contrary, they received new positions. And the front company also won a billion-dollar tender for road repairs.

We would like to note that the heads of regional military administrations are personally appointed by President Volodymyr Zelensky, and their work is supervised by the head of his office, [5.1.2e] [5.1.2e]

In addition, we were very outraged by the media report of 09/22/2025 – "The Territorial Military Center made a proposal": [512e] reported on mobilization – https://www.pravda.com.ua/news/2025/09/22/7532016/.

Journalist and editor-in-chief of the journalistic investigation project on top corruption in Ukraine Bihus. Info announced that he is going to serve again.

Bigus recalled that at the beginning of the full-scale Russian invasion, he voluntarily joined the ranks of the Armed Forces of Ukraine, served for two years, and later resigned – but still does not have the status of a combatant, which the Ministry of Internal Affairs must provide.

In addition, on October 1, 2025, a new report appeared in the media that an employee of the central apparatus of the Security Service of Ukraine came to the apartment of the executive director of The Kyiv Independent and spied on her - <a href="https://www.pravda.com.ua/news/2025/10/01/8000759/">https://www.pravda.com.ua/news/2025/10/01/8000759/</a>. The Security Service of Ukraine confirmed this.

This is nothing more than a new round of pressure on independent journalists and public figures in Ukraine!

As we indicated in our previous appeal, on August 30, 2025, in broad daylight in the city of Lviv, Andriy Parubiy, a current People's Deputy of Ukraine and Speaker of the Verkhovna Rada of Ukraine from 2016 to 2019, was brutally shot (8 bullets).

Andriy Parubiy was a great patriot of Ukraine, a member of the opposition party, a critic not only of the Russian authorities, but also of the current leaders in

Ukraine, and especially of corruption. Unfortunately, attacks on opposition politicians and public figures in Ukraine have already become common practice. According to President Volodymyr Zelenskyy, the main theory behind this murder (as in all cases) is that Russia is involved and that the war is to blame, although we find this hard to believe. If this is the case, it would not have happened if the Security Service of Ukraine, the State Bureau of Investigations and the Office of the Prosecutor General had really been working at full capacity, rather than carrying out political instructions from the Office of the President of Ukraine under the leadership of Andriy Yermak, which always ends in persecution in Ukraine.

At the same time, according to the already detained suspect himself, this murder is in no way connected with Russia, but is connected with the actions of the authorities in Ukraine, and he was also planning an assassination attempt on the fifth President of Ukraine Petro Poroshenko. Of course, the people who ordered the murder of Hero of Ukraine Andriy Parubiy were never identified.

According to the majority in Ukraine, this political execution is another milestone in the struggle for power in Ukraine in the upcoming elections and another act of intimidation. We hope we won't be next, like patriot Andriy Parubiy.

The real owner of Fire Point may be a friend of President Volodymyr Zelenskyy and co-founder of the Kvartal 95 studio, <sup>5.1.2e</sup>

Also, regarding negotiations on the territory of Ukraine, in accordance with Articles 2 and 5 of the Constitution of Ukraine (https://zakon.rada.gov.ua/laws/show/254%D0%BA/96-

%D0%B2%D1%80# Text), the territory of Ukraine within its existing borders is indivisible and inviolable; the right to determine and change the constitutional order in Ukraine belongs exclusively to the people and cannot be usurped by the state, its bodies or officials. According to Article 157, the Constitution of Ukraine cannot be amended if the amendments provide for the abolition or restriction of human and civil rights and freedoms or are aimed at eliminating the independence or violating the territorial integrity of Ukraine.

Therefore, civil society, the military and lawyers in Ukraine generally do not understand on what basis and under what laws Ukrainian President Volodymyr Zelensky intends to sign any peace agreements involving Ukrainian territories

(agreements on changes to Ukraine's territory would be a gross violation of the Ukrainian Constitution and international law).

Furthermore, encroachment on the territorial integrity and inviolability of Ukraine is a serious criminal offense under Article 110 of the Criminal Code of Ukraine. Another new anti-corruption investigation (one of countless others) by the Anti-Corruption Center, in conjunction with opposition MPs, into corruption in the State Customs Service of Ukraine and the State Tax Service of Ukraine, where a total of 200 billion is lost annually, has also caused public outrage - <a href="https://www.youtube.com/watch?v=NUrk5-kOXAQ">https://www.youtube.com/watch?v=NUrk5-kOXAQ</a>.

Due to the excessive arrogance of the Ukrainian authorities, protests continued throughout July 2025, involving mainly young people and the military, to prevent the return of the authoritarianism of President Yanukovych's era!

Thus, on 22.07.2025, the Verkhovna Rada of Ukraine, on the initiative and under pressure from President of Ukraine Volodymyr Zelenskyy and the head of his Office, <sup>512e</sup> adopted Law No. 12414, which eliminates the independence of anti-corruption bodies - the National Anti-Corruption Bureau of Ukraine and the Specialised Anti-Corruption Prosecutor's Office, turning them into units of the under-reformed and politically dependent prosecutor's office, and significantly limits the effectiveness of these bodies, depriving them of the ability to maintain the confidentiality of investigations into top corrupt officials.

In essence, this means the destruction of one of the most important factors that keeps the doors to the European Union open for Ukraine, ensures the trust and support of European partners, which is vital in times of war, and nourishes the Ukrainian dream of a better future, which gives people strength at the front and at the rear.

Among other things, this creates grounds for rolling back the existing achievements of European integration and increases financial risks for the country.

The events are very well described in the article 'At night, the Russians attack. The request made by Ukraine's journalistic and civil society community to all of you, our international partners, in a public appeal is also very eloquent: «Silence kills democracy. Western partners must change their policy towards Ukraine» - https://www.eurointegration.com.ua/articles/2025/07/25/7216690/.

Along with the disruption of the reboot of the Bureau of Economic Security of Ukraine - in violation of Article 15 of the Law of Ukraine 'On the Bureau of Economic Security of Ukraine', the winner of the independent competition, detective of the National Anti-Corruption Bureau of Ukraine Oleksandr Tsyvinskyi, was simply not appointed for no reason - and the High Qualification Commission of Judges - the judicial body was simply 'destroyed from within',

which happened on the instructions of the Head of the Office of the President of Ukraine the application of politically motivated selective justice against civil society activists, military personnel, journalists, etc. creates a sense of returning to 2013, when Ukraine's geopolitical and civilisational choice had not yet been made.

But, unfortunately, we state that all appeals are ignored, that is, during the war and devastation, the leadership of the state of Ukraine ignores the opinion of the people of Ukraine!

A very good example and proof of this is the fact that on 31 July 2025, the Verkhovna Rada of Ukraine adopted Presidential Law No. 13533, which supposedly restores the independence of anti-corruption bodies.

But almost no one paid attention to one seemingly insignificant legal detail: thanks to this law (amendments to Article 36 of the Criminal Procedure Code of Ukraine), authored by Volodymyr Zelenskyy, the dependent Prosecutor General received new powers, namely the right to transfer investigations from NABU to another body in the event of unclear objective circumstances that allegedly make it impossible for the National Anti-Corruption Bureau of Ukraine to function or conduct pre-trial investigations under martial law.

Thus, Volodymyr Zelensky defended and showed leniency towards the head of the Presidential Office, <sup>51,2e</sup> and his deputies, i.e. the president's closest associates, since now the Prosecutor General can, under the pretext of martial law, take any case away from the independent NABU, especially those involving top corrupt officials.

According to current Ukrainian legislation, the Prosecutor General is not independent of the orders of the Head of the Presidential Administration and the President of Ukraine.

And even if the unconstitutional law is almost amended as a result of public outcry and international pressure, the idea of concentrating all power in Ukraine in one set of hands will, unfortunately, still be implemented, as already announced by the director of NABU and demonstrated by the aforementioned presidential law. This is evidenced by the numerous searches conducted in recent months by detectives from the National Anti-Corruption Bureau and prosecutors from the Specialized Anti-Corruption Prosecutor's as well as their detention and obstruction of their work in investigating high-level corruption.

Unfortunately, we are not surprised, because a new journalistic investigation of 30.07.2025 proves how the supervisor of subsoil in Ukraine - a confidant of Volodymyr Zelenskyi and Andriy Yermak - lives and where the President of Ukraine himself often visited - TAPPING MINDICH'S

APARTMENT: "ZELENSKY'S HOLIDAY and the GOLDEN TOILET. This is where the list of the Servant of the People faction to the Verkhovna Rada of Ukraine was selected" – <a href="https://www.youtube.com/watch?v=gV0mnQJX6vs">https://www.youtube.com/watch?v=gV0mnQJX6vs</a>.

If the dear President of Ukraine Volodymyr Zelenskyy and the head of his office, Andriy Yermak, respected national and international law, they would not only prevent all that is happening in Ukraine, which has nothing to do with the war, but also fulfil the requirements of the Constitution of Ukraine.

For example, Volodymyr Zelenskyy has been President of Ukraine for 7 years, contrary to the requirements of Article 103 of the Constitution of Ukraine, which provides for a term of office of 5 years.

President Volodymyr Zelenskyy should have resigned at the end of his five-year term in accordance with Articles 108-109 of the Constitution of Ukraine, rather than attempting to concentrate all power in one centre – the Office of the President of Ukraine, headed by his right-hand man Andriy Yermak.

And the war and martial law are not an obstacle to free and democratic elections in Ukraine, as the practice of recent weeks has shown that Article 10 of the Law of Ukraine 'On the Legal Regime of Martial Law', which allegedly prohibits the election of the President of Ukraine, can be easily changed, although the Constitution of Ukraine does not contain such a prohibition, as martial law did not prevent the change of the Government of Ukraine headed by on 17 July 2025, which is now fully controlled by the Office of the President of Ukraine, which was even publicly confirmed by President Zelensky himself.

Also, outright repressions and pressure on civil society activists have now begun. For example, on 11 July 2025, the head of the Anti-Corruption Action Centre,

51.2e was detained under false pretences in a two-year-old case, and searches were conducted without a court order, brazenly and illegally.

Law enforcement agencies, such as the State Bureau of Investigation and the Security Service of Ukraine, have recently been acting brazenly - detaining undesirable public figures under false pretences, conducting searches at their own discretion without court orders, and then exerting pressure!

We, as a human rights organisation, have also started receiving threats in the form of 'warnings' because of our active civic position! We receive the same information from the Honorary Chairman of our organisation, <sup>51,2e</sup>

who receives warnings that he will be next after Shabunin!

The population of Ukraine has now formed a general and persistent impression that Ukraine, under the current leadership of the state, is returning to the times of Stalin's terror of 1937-1938.

We also received damning information about the illegal and unlawful actions of prosecutors of the Prosecutor General's Office and investigators of the State Bureau of Investigation together with officials and employees of the State Institution Ukrainian State Research Institute of Medical and Social Problems of Disability of the Ministry of Health of Ukraine.

According to the Order of the Ministry of Health of Ukraine dated 03 December 2024, the State Institution 'Ukrainian State Research Institute of Medical and Social Problems of Disability of the Ministry of Health of Ukraine' is vested with the rights and obligations of the Centre for Assessment of Functional Status of a Person. The Centre for the Assessment of Functional Status of a Person began reviewing medical expert cases on 1 January 2025, after the termination of the activities of the CMEC. The NSDC Decision of 22 October 2024, enacted by the Decree of the President of Ukraine No. 732/2024 of 22 October 2024, instructed officials of state bodies to conduct a working group review of the validity of the MSEC decisions on disability determination, and in case of unjustified decisions, to initiate their review in accordance with the established procedure.

Subsequently, the prosecutors of the Prosecutor General's Office and investigators of the State Bureau of Investigation sent instructions to the said State Institution of the Ministry of Health to review the disability status of a number of persons whose disability status was cancelled without proper consideration and examination. At the same time, court decisions in the name of Ukraine have already cancelled such illegal decisions of the Centre for the Assessment of the Functional Status of a Person. For example, the decisions of administrative courts in cases No. 580/1755/25 - <a href="https://reyestr.court.gov.ua/Review/127057542">https://reyestr.court.gov.ua/Review/127057542</a>, No. 580/618/25 - <a href="https://reyestr.court.gov.ua/Review/126816435">https://reyestr.court.gov.ua/Review/126816435</a>, cancelled the decisions of the State Institution 'Ukrainian State Research Institute for Medical and Social Problems of Disability of the Ministry of Health of Ukraine' and declared their actions unlawful.

As we know and have already been established by the courts, the review of disabilities was carried out in flagrant violation of Ukrainian law, and even in the absence of the MSEC files that established disability, as they were seized by SBI investigators and no one knows where they are at the moment.

It is outrageous and cynical that among those whose disability status has been cancelled is a person who has already died!

This raises the natural question of how the prosecutors of the Prosecutor General's Office and investigators of the State Bureau of Investigation initiated and conducted the assessment of the daily functioning of the deceased person.

At present, according to the Judiciary of Ukraine sources, hundreds of similar cases are pending in the administrative courts of Ukraine regarding the illegal actions of the State Institution 'Ukrainian State Research Institute of Medical and Social Problems of Disability of the Ministry of Health of Ukraine' to cancel illegal decisions and declare their actions unlawful.

Unfortunately, this was only the beginning! In 2025, the terror of Ukrainian citizens with disabilities only intensified and continued. Now, allegedly for the purpose of proper pre-trial investigation within criminal proceedings, prosecutors of the Prosecutor General's Office and investigators of the State Bureau of Investigation, without the rulings of investigating courts and court decisions, have

sent to the State Institution 'Ukrainian State Research Institute of Medical and Social Problems of Disability of the Ministry of Health of Ukraine' an order to review the disability of thousands of people who have nothing to do with these criminal proceedings and who have not been subject to investigative actions in relation to each other. In other words, without investigation and court decision, the requirements for disability review are sent to fulfil possibly illegal instructions from their superiors.

In turn, officials and employees of the State Institution 'Ukrainian State Research Institute for Medical and Social Problems of Disability of the Ministry of Health of Ukraine' illegally initiated the procedure for reviewing disabilities on the basis of these unreasonable orders, because, according to sources from the State Institution itself, such a political instruction is to cancel disabilities for everyone, no matter what.

Unfortunately, these actions of the prosecutors of the Office of the Prosecutor General and investigators of the State Bureau of Investigation, together with officials and employees of the State Institution 'Ukrainian State Research Institute for Medical and Social Problems of Disability of the Ministry of Health of Ukraine' only distort the reform of the assessment of the functional state of a person in Ukraine, grossly violating human rights!

Such terror against Ukrainian citizens and arrogance, which cannot be called anything else, did not even exist during the criminal rule of Ukrainian President

The above may not only contribute to reputational losses on the international arena, but also threaten Ukraine's European integration processes.

As a result, the director of the State Bureau of Investigations, Oleksiy Sukhachov, and his agency have become "famous" for persecuting disabled people over the past year, while corruption within the agency and corruption in the upper echelons of power in Ukraine have somehow been forgotten.

Also, media outlets have recently reported significant pressure from the Office of the President of Ukraine, headed by its head Andriy Yermak, to prevent them from further publishing investigations and exposés of the large corps, which Mr Yermak is likely to be covering up.

For example, 09.10.2024 information was published about the pressure exerted on independent media by the Office of the President of Ukraine and, of course, its head, Andriy Yermak and his advisers «Ukrayinska Pravda claims systemic pressure from the President's Office» - <a href="https://www.pravda.com.ua/columns/2024/10/9/7478844/">https://www.pravda.com.ua/columns/2024/10/9/7478844/</a>.

According to the statement, the journalists want to draw the attention of colleagues, partners and international organisations to the ongoing and systematic pressure exerted by the Presidential Office on the editorial office and individual journalists of Ukrayinska Pravda.

These and other non-public signals indicate attempts to influence our editorial policy. It is especially outrageous to realise this at a time of Russia's full-scale

invasion of Ukraine, when our joint struggle for both survival and democratic values is essential.

We would like to emphasise that these publications are actively involved in conducting investigative journalism on grand corruption and signs of usurpation of power in Ukraine, which is openly justified and covered up by the Head of the Office of the President of Ukraine, Andriy Yermak.

After analysing open sources, we drew attention to <sup>51,2e</sup> a prosecutor at the Kyiv City Prosecutor's Office, who has been publicly accused of something in recent years, but after examining publicly published documents about him, the accusations are not confirmed.

In addition, prosecutor of the interview is the only one who has not been afraid to speak publicly and give interviews to national TV channels recently, because he most likely has nothing to fear, which cannot be said about others. Even from the information received in recent days, most of the employees of the prosecutor's office of Ukraine, after the resignation of the tainted Prosecutor General Kostin, have now all started to say that Ukraine needs a new Prosecutor General, like of the said of pressure and telling the truth.

Currently, after numerous threats and pressure, <sup>5.12e</sup> Zakharchenko resigned, and now, as the Honorary Chairman of the NGO 'Legal Equality', continues to defend human and civil rights in Ukraine!

However, an apparently honest Prosecutor General would not be beneficial to the head of the Office of the President of Ukraine, <sup>51,2e</sup> because then his friends would not be able to do what they want.

One of the confirmations of this is the consent of the Verkhovna Rada of Ukraine on 17.06.2025 to the appointment of Ruslan Kravchenko as Prosecutor General. The appointment of Ruslan Kravchenko as Prosecutor General was a gross violation of Article 131-1 of the Constitution of Ukraine, paragraph 4 of part 40 of the Law of Ukraine 'On the Prosecutor's Office' and especially part 4 of Article 212 of the Law of Ukraine 'On the Rules of Procedure of the 51.2e of Ukraine' - when the President of Ukraine is legally obliged to be present in the Parliament in person, and not to be in another part of the world at that time. Therefore, it is not surprising that the Chairman of the Rada, Ruslan Stefanchuk, was also absent for some reason!

The situation was ridiculous, as if 5.1.2e did not know where else to offer and appoint him.

51.2e 51.2e 's leadership of the Kyiv Regional Military Administration and the State Tax Service of Ukraine has not brought anything good in recent years, as practice has shown, either constant corruption public scandals or simply nothing!

According to even open sources, in February 2023, <sup>51,2e</sup> took part in the competition for the position of the head of the National Anti-Corruption Bureau of Ukraine. On 7 April 2023, the Cabinet of Ministers approved and on

10 April 2023, President Volodymyr Zelenskyy appointed 5.1.2e as the Head of the Kyiv Regional State Administration by his Decree No. 204/2023, and later appointed him as the Head of the State Tax Service of Ukraine, at a time when he and his parents had questions about paying taxes after buying a house. His 'successful career' is also surprising: in 2019, 5.1.2e first privatised the prosecutor's office apartment and then quickly sold it. In April 2023, activist 5.1.2.e reported that a year earlier, 5.1.2.e illegally opened a criminal case against MP 61.2e Only the head of the Prosecutor General's Office can initiate cases against MPs, and this is the jurisdiction of the NABU. In other words, 5.1.2e 5.1.2.e decided to dispense with the sanction of his superior in this matter. Interestingly, the coverage of the case began with Lovochkin's websites, which distributed extracts from the URPI, and 5.1.2.e 's father-in-law was in charge of the regional healthcare department under the odious head of the Chernivtsi region, Papiyev. His wife was an assistant to another 5.1.2.e protege, 5.1.2.e (who ran ChernivtsiGaz and was an MP under the Party of Regions). 512e himself 5.1.2.e worked in the military prosecutor's office under the leadership of 5.1.2e who was very good at his job. According to open sources and his biography, apart from being a 'good performer' for the Presidential Office, he has done nothing good for his department in recent years, such as the promised tax reform, which is mired in corruption and political execution. like all prosecutors in Ukraine, also avoided the certification of prosecutors, because there were too many questions about his integrity. We were aware of this candidacy, so back in March 2025, we sent an appeal to all members of the Ukrainian parliament calling on them not to give their consent to the appointment of 5.1.2.e 5.1.2.e as Prosecutor General, outlining all the facts, and received official assurances that this would not happen. His appointment as Prosecutor General in violation of the laws and the Constitution of Ukraine is a cynical spit in the face of civil society and the people of Ukraine, as well as the entire international community. The unlawful appointment of 5.1.2e who is 5.1.2.e 's man. to the top position of the prosecutor's office, which is supposed to oversee the rule of law, is epic and brazen! At the same time, the media published another corporate journalistic investigation by June https://zaxid.net/simya zastupnika genprokurora kupila elitne mayno ta vive zla milyoni gotivki za kordon n1611874 and https://hromadske.ua/suspilstvo/245854-kruzak-iz-milyonom-dolariv-iak-zyverodyna-zastupnyka-henprokurora - «Family of Deputy Prosecutor General 5.1.2e bought luxury property and took millions in cash abroad». According to the investigation, during the full-scale war, relatives of Ukraine's Deputy Prosecutor General 5.1.2.e became significantly wealthier: they

purchased elite real estate in Kyiv and Chernivtsi, as well as cars worth hundreds of thousands of dollars. In addition, the official's father took \$1.1 million and €100,000 in cash to Romania, which he did not declare.

According to investigators, the deputy prosecutor general's mother has been selling food from stalls and markets since 2008. In 2021-2024, her annual income was about 1 million hryvnia.

's father, <sup>51/2e</sup> has been a construction entrepreneur since 2017. In 2024, he became a co-founder of the construction company V.D. GROUP Kolomyia, which suffered losses of almost 100,000 hryvnia in its first year of operation.

So where did the millions of dollars come from? It remains a mystery!

In March 2022, the Deputy Prosecutor General's father took \$1.1 million and €100,000 in cash to Romania without declaring it. Customs fined the man UAH 1,700, but he appealed the fine in court.

Interestingly, after this incident, <sup>512e</sup> declared his wife's bank account in Romania, the time of its opening coinciding with his father's trip.

Unfortunately, the Ukrainian authorities are currently hushing up this fact, and have not even launched an official investigation, and the question is already addressed to the current Prosecutor General - where did the tax service look at these undeclared millions of dollars when he was in charge? Also, according to journalisti and civic investigations of 24.03.2025, is how, while Ukrainian society's attention is focused on negotiations in Saudi Arabia, a firm that disrupts military procurement contracts may receive additional tens of billions of hryvnias – «A new SCANDAL with military procurement. A shocking new investigation has revealed how it happened that 78 billion hryvnias from the budget of the Ministry of Defence are transferred to the State Border Guard Service, while military procurement is carried out through the Polish intermediary company PHU Lechmar Sp. z o.o., which has already been involved in the disruption of a 23 billion contract in 2024. In 2024, 87% of all military procurement by the State Border Guard Service went through this intermediary.

In February 2025, the Ministry of Defence transferred another UAH 78 billion for similar purchases of ammunition for border guards.

It is cynical that hundreds of billions of hryvnias are spent, but half of the military ammunition does not reach the military!

According to MP 51.2e these decisions were made by the First Deputy of the Ministry of Defence who is currently in charge of procurement and is close to the head of the Office of the President of Ukraine whose trusted man is now an advisor to the minister, 51.2e

5.1.2.e who was dismissed from his post as 5.1.2e deputy in 2024 following corruption scandals. At the same time, 61.2e O.O. was repeatedly seen in the building of the Kyiv City Prosecutor's Office, where he held meetings and conferences. His first deputy in the Odessa Regional State Administration is 5.12e 5.1.2.e a former prosecutor of the Kyiv City Prosecutor's Office, who fled to avoid lustration! who also held high-ranking positions under the Incidentally, 5.1.2.e leadership of the criminal Prosecutor 5.1.2e 5.1.2.e is also subject to vetting. but strangely avoided it and did not pass certification. Subsequently, brazenly using the provisions of the Law of Ukraine "On the Legal Regime of Martial Law" (according to the response of Ministry of Community, **Territorial** and the Infrastructure Development of Ukraine), in agreement with the General Staff of the Armed Forces of Ukraine and the Cabinet of Ministers of Ukraine, Kiper was appointed by Presidential Decree as the Head of the Odesa Regional Military Prosecutor's Office, where he has been until now. Only the deaf have never heard of his «corrupt activities».

According to the investigation, at the end of last year, we heard startling information from sources in business circles. More than ten Ukrainians ordered a new electric Rolls-Royce Spectre worth more than half a million euros.

The Spectre is Rolls-Royce's first electric car, which began production in 2023. You can't buy such a car in a showroom. Especially as a full-scale war is ongoing in Ukraine. And those Ukrainian citizens who really wanted to become one of the world's first owners of such expensive cars had to queue up and wait.

As of now, according to 51.2e s sources in law enforcement, 13 Rolls-Royce Spectres have already been registered in Ukraine. Some of these cars are already compromising our country on the streets of the Principality of Monaco.

In addition, according to a journalistic investigation on 25.02.2025 - <a href="https://www.youtube.com/watch?v=3kc6fDJW0HY">https://www.youtube.com/watch?v=3kc6fDJW0HY</a> - how to hide sanctioned persons in Europe and Dubai!

This is not surprising, as the journalistic community has repeatedly pointed this out.

Their number is already in the dozens.

However, the law enforcement agencies of Ukraine and the Office of the President of Ukraine, headed by Andriy Yermak, prefer not to notice this!

The business of sanctioned persons continues to flourish in Ukraine in full swing, despite the seemingly imposed sanctions.

At the same time, without an investigation and a court decision, by Decree of President Volodymyr Zelensky No. 81/2025 of February 12, 2025, sanctions were imposed on the fifth President of Ukraine, Petro Poroshenko, which are based on false grounds and without proper documents.

No matter how critical our organization is of [51.2e] this is already too much, because this People's Deputy of Ukraine was not even going to run away! All of the above is unacceptable for Ukraine, which is a candidate for membership in the European Union. Such impudence did not occur even under the criminal rule of the President of <sup>5.1.2.6</sup>

Repeated appeals to the President of Ukraine, the Prime Minister of Ukraine, the Heads of the Security Service of Ukraine, National Anti-Corruption Bureau of Ukraine, the Prosecutor General, other investigative and law enforcement agencies of Ukraine, G7 ambassadors, the EU Delegation to Ukraine, the leadership of the <sup>5.12e</sup> of Ukraine, all members of the Verkhovna Rada of Ukraine (specialised committees) have not yielded any results.

All investigations, even when the National Agency for the Prevention of Corruption exposes facts of corruption and illicit enrichment, are stopped by with the help of the hands of the Prosecutor General's Office and the Security Service of Ukraine, as well as by pressure on everyone without exception, no one is punished, corruption continues, and those involved behave even more brazenly!

First of all, after more than 1,320 days of a terrible and brutal war, we would like to sincerely thank You, Your Countries and the Peoples of the Kingdom of the Netherlands for helping Ukrainians and the state of Ukraine in this difficult time of unprovoked armed aggression by Russia!

As a human rights organization operating since 2011, we have repeatedly received information about egregious cases of the destruction of democracy, suppression of freedom of speech, and gross violations of human rights, usurpation of power, high-level corruption, and nepotism among the leadership of Ukraine's law enforcement system and ruling elite.

We would like to emphasize and draw your attention to the fact that the information and facts recently presented in the world media are the honest truth and realities of modern Ukraine, no matter how Volodymyr Zelensky and 512e justify themselves. The facts speak for themselves!

Also, we fully agree and confirm the facts expressed on October 1, 2025 by the Head of the Specialized Anti-Corruption Prosecutor's Office, of the Specialized Anti-Corruption of the Specialized Anti-Corruption Prosecutor's Office, of the Specialized Anti

According to him, we as a human rights organization fully confirm what was said, that the Ukrainian authorities demonstrate political will to fight domestic corruption, but do not show the same desire or will to overcome top corruption among the highest state officials. He means the top leaders of the state of Ukraine, who are very close to President Volodymyr Zelensky!

Therefore, recent events have forced us to finally break our silence, despite direct threats against our team and pressure from the Security Service of Ukraine (after recent appeals to you by international partners and the international community), especially against the former prosecutor of the Kyiv City Prosecutor's Office and honorary chairman of our organization, 5.1.2.6

On September 5, 2025, in the city of Sumy, well-known journalist 512e 512e famous for his investigations into corruption in the construction of fortifications for the Armed Forces of Ukraine, was found dead (shot) - https://suspilne.media/sumy/1108518-na-sumsini-pomer-zurnalist-oleksandr-tahtaj/.

After systematically publishing articles about government corruption, he began receiving threats. In August, someone fired an unknown weapon at the window of Takhtay's dacha, and a smoke grenade was found in his apartment. The law enforcement agencies he contacted on the eve of his murder did nothing!

Also, the news that the National Anti-Corruption Bureau of Ukraine had launched an investigation into possible corruption abuses by the heads of the Poltava Regional Military Administration during the construction of fortifications caused a great public outcry - https://suspilne.media/amp/poltava/1106562-nabu-rozpocalo-rozsliduvanna-sodo-rozkradanna-kostiv-na-fortifikaciah-u-poltavskij-oblasti/ and https://www.5.ua/regiony/miliony-na-butaforiiu-fortyfikatsii-na-donechchyni-vyiavylysia-feikom-khto-zaimavsia-obrudkoiu-359214.html.

This was reported by People's Deputy 51.2e who published the NABU's official response to his appeal.

As is known, the investigation revealed that in 2024, the Poltava Regional Military Administration spent UAH 372 million on the construction of fortifications in Donetsk Oblast, but at least UAH 200 million of these funds disappeared due to schemes involving "front" companies, inflated prices, and fictitious contracts. Previously, materials related to this case were being investigated by the Economic Security Bureau in Poltava region and the Department of Strategic Investigations.

According to the investigation, at that time, the Poltava Regional State Administration was headed by 51.20 who currently heads the State Financial Monitoring Service. His deputies were also not punished; on the contrary, they received new positions. And the front company also won a billion-dollar tender for road repairs.

We would like to note that the heads of regional military administrations are personally appointed by President Volodymyr Zelensky, and their work is supervised by the head of his office, 51.2e 51.2e

In addition, we were very outraged by the media report of 09/22/2025 – "The Territorial Military Center made a proposal": 51.2e reported on mobilization – https://www.pravda.com.ua/news/2025/09/22/7532016/.

Journalist and editor-in-chief of the journalistic investigation project on top corruption in Ukraine Bihus.Info 51.2e announced that he is going to serve again.

Bigus recalled that at the beginning of the full-scale Russian invasion, he voluntarily joined the ranks of the Armed Forces of Ukraine, served for two years, and later resigned – but still does not have the status of a combatant, which the Ministry of Internal Affairs must provide.

As we indicated in our previous appeal, on August 30, 2025, in broad daylight in the city of Lviv, <sup>5.12e</sup> a current People's Deputy of Ukraine and Speaker of the of Ukraine from 2016 to 2019, was brutally shot (8 bullets).

Andriy Parubiy was a great patriot of Ukraine, a member of the opposition party, a critic not only of the Russian authorities, but also of the current leaders in Ukraine, and especially of corruption. Unfortunately, attacks on opposition politicians and public figures in Ukraine have already become common practice.

According to President Volodymyr Zelenskyy, the main theory behind this murder (as in all cases) is that Russia is involved and that the war is to blame, although we find this hard to believe. If this is the case, it would not have happened if the Security Service of Ukraine, the State Bureau of Investigations and the Office of the Prosecutor General had really been working at full capacity, rather than carrying out political instructions from the Office of the President of Ukraine under the leadership of of the President of Ukraine under the leadership of the presecution in Ukraine.

At the same time, according to the already detained suspect himself, this murder is in no way connected with Russia, but is connected with the actions of the authorities in Ukraine, and he was also planning an assassination attempt on the fifth President of Ukraine of the of

According to the majority in Ukraine, this political execution is another milestone in the struggle for power in Ukraine in the upcoming elections and another act of intimidation. We hope we won't be next, like patriot Andriy Parubiy.

Information released on 29 August 2025 that the National Anti-Corruption Bureau of Ukraine was investigating links between the manufacturer of Flamingo rockets and Mindich, who turned out to be the largest supplier to the Ministry of Defence, also caused widespread public outrage - https://kyivindependent.com/exclusive-maker-of-ukraines-prized-flamingo-cruise-missile-facing-corruption-

Also, regarding negotiations on the territory of Ukraine, in accordance with Articles 2 and 5 of the Constitution of Ukraine (https://zakon.rada.gov.ua/laws/show/254%D0%BA/96-%D0%B2%D1%80# Text), the territory of Ukraine within its existing borders is indivisible and inviolable; the right to determine and change the constitutional order in Ukraine belongs exclusively to the people and cannot be usurped by the state, its bodies or officials. According to Article 157, the Constitution of Ukraine cannot be amended if the amendments provide for the abolition or restriction of human and civil rights and freedoms or are aimed at eliminating the independence or violating the territorial integrity of Ukraine.

Therefore, civil society, the military and lawyers in Ukraine generally do not understand on what basis and under what laws Ukrainian President Volodymyr Zelensky intends to sign any peace agreements involving Ukrainian territories (agreements on changes to Ukraine's territory would be a gross violation of the Ukrainian Constitution and international law).

Furthermore, encroachment on the territorial integrity and inviolability of Ukraine is a serious criminal offense under Article 110 of the Criminal Code of Ukraine.

Another new anti-corruption investigation (one of countless others) by the Anti-Corruption Center, in conjunction with opposition MPs, into corruption in the State Customs Service of Ukraine and the State Tax Service of Ukraine, where a total of 200 billion is lost annually, has also caused public outrage - https://www.youtube.com/watch?v=NUrk5-kOXAO.

Due to the excessive arrogance of the Ukrainian authorities, protests continued throughout July 2025, involving mainly young people and the military, to prevent the return of the authoritarianism of President 5.1.2e 's era!

Thus, on 22.07.2025, the Verkhovna Rada of Ukraine, on the initiative and under pressure from President of Ukraine Volodymyr Zelenskyy and the head of his Office, Andriy Yermak, adopted Law No. 12414, which eliminates the independence of anti-corruption bodies - the National Anti-Corruption Bureau of Ukraine and the Specialised Anti-Corruption Prosecutor's Office, turning them into units of the under-reformed and politically dependent prosecutor's office, and significantly limits the effectiveness of these bodies, depriving them of the ability to maintain the confidentiality of investigations into top corrupt officials.

In essence, this means the destruction of one of the most important factors that keeps the doors to the European Union open for Ukraine, ensures the trust and support of European partners, which is vital in times of war, and nourishes the Ukrainian dream of a better future, which gives people strength at the front and at the rear.

Among other things, this creates grounds for rolling back the existing achievements of European integration and increases financial risks for the country.

The events are very well described in the article 'At night, the Russians attack. The request made by Ukraine's journalistic and civil society community to all of you, our international partners, in a public appeal is also very eloquent: «Silence kills democracy. Western partners must change their policy towards Ukraine» - https://www.eurointegration.com.ua/articles/2025/07/25/7216690/.

Along with the disruption of the reboot of the Bureau of Economic Security of Ukraine - in violation of Article 15 of the Law of Ukraine 'On the Bureau of Economic Security of Ukraine', the winner of the independent competition, detective of the National Anti-Corruption Bureau of Ukraine 512e was simply not appointed for no reason - and the High Qualification Commission of Judges - the judicial body was simply 'destroyed from within', which happened on the instructions of the Head of the Office of the President of Ukraine 512e the application of politically motivated selective justice against civil society activists, military personnel, journalists, etc. creates a sense of

returning to 2013, when Ukraine's geopolitical and civilisational choice had not yet been made.

But, unfortunately, we state that all appeals are ignored, that is, during the war and devastation, the leadership of the state of Ukraine ignores the opinion of the people of Ukraine!

A very good example and proof of this is the fact that on 31 July 2025, the of Ukraine adopted Presidential Law No. 13533, which supposedly restores the independence of anti-corruption bodies.

But almost no one paid attention to one seemingly insignificant legal detail: thanks to this law (amendments to Article 36 of the Criminal Procedure Code of Ukraine), authored by Volodymyr Zelenskyy, the dependent Prosecutor General received new powers, namely the right to transfer investigations from NABU to another body in the event of unclear objective circumstances that allegedly make it impossible for the National Anti-Corruption Bureau of Ukraine to function or conduct pre-trial investigations under martial law.

Thus, Volodymyr Zelensky defended and showed leniency towards the head of the Presidential Office, <sup>512e</sup> and his deputies, i.e. the president's closest associates, since now the Prosecutor General can, under the pretext of martial law, take any case away from the independent NABU, especially those involving top corrupt officials.

According to current Ukrainian legislation, the Prosecutor General is not independent of the orders of the Head of the Presidential Administration and the President of Ukraine.

And even if the unconstitutional law is almost amended as a result of public outcry and international pressure, the idea of concentrating all power in Ukraine in one set of hands will, unfortunately, still be implemented, as already announced by the director of NABU and demonstrated by the aforementioned presidential law.

This is evidenced by the numerous searches conducted in recent months by detectives from the National Anti-Corruption Bureau and prosecutors from the Specialized Anti-Corruption Prosecutor's Office, as well as their detention and obstruction of their work in investigating high-level corruption.

Unfortunately, we are not surprised, because a new journalistic investigation of 30.07.2025 proves how the supervisor of subsoil in Ukraine - a confidant of Volodymyr Zelenskyi and 512e - lives and where the President of Ukraine himself often visited - TAPPING MINDICH'S APARTMENT: "ZELENSKY'S HOLIDAY and the GOLDEN TOILET. This is where the list of the Servant of the People faction to the Verkhovna Rada of Ukraine was selected" - https://www.youtube.com/watch?v=gV0mnQJX6vs.

If the dear President of Ukraine Volodymyr Zelenskyy and the head of his office,

512e respected national and international law, they would not only prevent all
that is happening in Ukraine, which has nothing to do with the war, but also fulfil the
requirements of the Constitution of Ukraine.

For example, Volodymyr Zelenskyy has been President of Ukraine for 7 years, contrary to the requirements of Article 103 of the Constitution of Ukraine, which provides for a term of office of 5 years.

President Volodymyr Zelenskyy should have resigned at the end of his five-year term in accordance with Articles 108-109 of the Constitution of Ukraine, rather than attempting to concentrate all power in one centre – the Office of the President of Ukraine, headed by his right-hand man 512e 512e

And the war and martial law are not an obstacle to free and democratic elections in Ukraine, as the practice of recent weeks has shown that Article 10 of the Law of Ukraine 'On the Legal Regime of Martial Law', which allegedly prohibits the election of the President of Ukraine, can be easily changed, although the Constitution of Ukraine does not contain such a prohibition, as martial law did not prevent the change of the Government of Ukraine headed by 512e on 17 July 2025, which is now fully controlled by the Office of the President of Ukraine, which was even publicly confirmed by President Zelensky himself.

Also, outright repressions and pressure on civil society activists have now begun.

For example, on 11 July 2025, the head of the Anti-Corruption Action Centre, <sup>5,12e</sup>

was detained under false pretences in a two-year-old case, and searches were conducted without a court order, brazenly and illegally.

Law enforcement agencies, such as the State Bureau of Investigation and the Security Service of Ukraine, have recently been acting brazenly - detaining undesirable public figures under false pretences, conducting searches at their own discretion without court orders, and then exerting pressure!

We, as a human rights organisation, have also started receiving threats in the form of 'warnings' because of our active civic position! We receive the same information from the Honorary Chairman of our organisation, <sup>5,1,2,e</sup> who receives warnings that he will be next after Shabunin!

The population of Ukraine has now formed a general and persistent impression that Ukraine, under the current leadership of the state, is returning to the times of Stalin's terror of 1937-1938.

We also received damning information about the illegal and unlawful actions of prosecutors of the Prosecutor General's Office and investigators of the State Bureau of Investigation together with officials and employees of the State Institution Ukrainian State Research Institute of Medical and Social Problems of Disability of the Ministry of Health of Ukraine.

According to the Order of the Ministry of Health of Ukraine dated 03 December 2024, the State Institution 'Ukrainian State Research Institute of Medical and Social Problems of Disability of the Ministry of Health of Ukraine' is vested with the rights and obligations of the Centre for Assessment of Functional Status of a Person. The Centre for the Assessment of Functional Status of a Person began reviewing medical expert cases on 1 January 2025, after the termination of the activities of the CMEC. The NSDC Decision of 22 October 2024, enacted by the Decree of the President of Ukraine No. 732/2024 of 22 October 2024, instructed officials of state bodies to conduct a working group review of the validity of the MSEC decisions on disability determination, and in case of unjustified decisions, to initiate their review in accordance with the established procedure.

Subsequently, the prosecutors of the Prosecutor General's Office and investigators of the State Bureau of Investigation sent instructions to the said State Institution of the Ministry of Health to review the disability status of a number of persons whose disability status was cancelled without proper consideration and examination. At the same time, court

decisions in the name of Ukraine have already cancelled such illegal decisions of the Centre for the Assessment of the Functional Status of a Person. For example, the decisions of administrative courts 580/1755/25 in https://reyestr.court.gov.ua/Review/127057542, No. 580/618/25 https://reyestr.court.gov.ua/Review/126549006 and No. 580/1672/25 https://reyestr.court.gov.ua/Review/126816435, cancelled the decisions of the State Institution 'Ukrainian State Research Institute for Medical and Social Problems of Disability of the Ministry of Health of Ukraine' and declared their actions unlawful.

As we know and have already been established by the courts, the review of disabilities was carried out in flagrant violation of Ukrainian law, and even in the absence of the MSEC files that established disability, as they were seized by SBI investigators and no one knows where they are at the moment.

It is outrageous and cynical that among those whose disability status has been cancelled is a person who has already died!

This raises the natural question of how the prosecutors of the Prosecutor General's Office and investigators of the State Bureau of Investigation initiated and conducted the assessment of the daily functioning of the deceased person.

At present, according to the Judiciary of Ukraine sources, hundreds of similar cases are pending in the administrative courts of Ukraine regarding the illegal actions of the State Institution 'Ukrainian State Research Institute of Medical and Social Problems of Disability of the Ministry of Health of Ukraine' to cancel illegal decisions and declare their actions unlawful.

Unfortunately, this was only the beginning! In 2025, the terror of Ukrainian citizens with disabilities only intensified and continued. Now, allegedly for the purpose of proper pre-trial investigation within criminal proceedings, prosecutors of the Prosecutor General's Office and investigators of the State Bureau of Investigation, without the rulings of investigating courts and court decisions, have sent to the State Institution 'Ukrainian State Research Institute of Medical and Social Problems of Disability of the Ministry of Health of Ukraine' an order to review the disability of thousands of people who have nothing to do with these criminal proceedings and who have not been subject to investigative actions in relation to each other. In other words, without investigation and court decision, the requirements for disability review are sent to fulfil possibly illegal instructions from their superiors.

In turn, officials and employees of the State Institution 'Ukrainian State Research Institute for Medical and Social Problems of Disability of the Ministry of Health of Ukraine' illegally initiated the procedure for reviewing disabilities on the basis of these unreasonable orders, because, according to sources from the State Institution itself, such a political instruction is to cancel disabilities for everyone, no matter what.

Unfortunately, these actions of the prosecutors of the Office of the Prosecutor General and investigators of the State Bureau of Investigation, together with officials and employees of the State Institution 'Ukrainian State Research Institute for Medical and Social Problems of Disability of the Ministry of Health of Ukraine' only distort the reform of the assessment of the functional state of a person in Ukraine, grossly violating human rights!

Such terror against Ukrainian citizens and arrogance, which cannot be called anything else, did not even exist during the criminal rule of Ukrainian President 6.12.6

The above may not only contribute to reputational losses on the international arena, but also threaten Ukraine's European integration processes.

As a result, the director of the State Bureau of Investigations, Oleksiy Sukhachov, and his agency have become "famous" for persecuting disabled people over the past year, while corruption within the agency and corruption in the upper echelons of power in Ukraine have somehow been forgotten.

Also, media outlets have recently reported significant pressure from the Office of the President of Ukraine, headed by its head Andriy Yermak, to prevent them from further publishing investigations and exposés of the large corps, which size is likely to be covering up.

For example, 09.10.2024 information was published about the pressure exerted on independent media by the Office of the President of Ukraine and, of course, its head, <sup>512e</sup> and his advisers «Ukrayinska Pravda claims systemic pressure from the President's Office» - https://www.pravda.com.ua/columns/2024/10/9/7478844/,

According to the statement, the journalists want to draw the attention of colleagues, partners and international organisations to the ongoing and systematic pressure exerted by the Presidential Office on the editorial office and individual journalists of <sup>5,12e</sup>

These and other non-public signals indicate attempts to influence our editorial policy. It is especially outrageous to realise this at a time of Russia's full-scale invasion of Ukraine, when our joint struggle for both survival and democratic values is essential.

We would like to emphasise that these publications are actively involved in conducting investigative journalism on grand corruption and signs of usurpation of power in Ukraine, which is openly justified and covered up by the Head of the Office of the President of Ukraine, 51.2e 51.2e

After analysing open sources, we drew attention to Yaroslav Zakharchenko, a prosecutor at the Kyiv City Prosecutor's Office, who has been publicly accused of something in recent years, but after examining publicly published documents about him, the accusations are not confirmed.

In addition, prosecutor 512e is the only one who has not been afraid to speak publicly and give interviews to national TV channels recently, because he most likely has nothing to fear, which cannot be said about others. Even from the information received in recent days, most of the employees of the prosecutor's office of Ukraine, after the resignation of the tainted Prosecutor General Kostin, have now all started to say that Ukraine needs a new Prosecutor General, like 512e who is really honest, outspoken and not afraid of pressure and telling the truth.

Currently, after numerous threats and pressure, <sup>5120</sup> resigned, and now, as the Honorary Chairman of the NGO 'Legal Equality', continues to defend human and civil rights in Ukraine!

However, an apparently honest Prosecutor General would not be beneficial to the head of the Office of the President of Ukraine, <sup>5.12e</sup> because then his friends would not be able to do what they want.

One of the confirmations of this is the consent of the Verkhovna Rada of Ukraine on 17.06.2025 to the appointment of Ruslan Kravchenko as Prosecutor General.

The appointment of Ruslan Kravchenko as Prosecutor General was a gross violation of Article 131-1 of the Constitution of Ukraine, paragraph 4 of part 40 of the Law of

Ukraine 'On the Prosecutor's Office' and especially part 4 of Article 212 of the Law of Ukraine 'On the Rules of Procedure of the Verkhovna Rada of Ukraine' - when the President of Ukraine is legally obliged to be present in the Parliament in person, and not to be in another part of the world at that time. Therefore, it is not surprising that the Chairman of the Rada, 51.26 was also absent for some reason!

The situation was ridiculous, as if Andriy Yermak did not know where else to offer and appoint him.

's leadership of the Kyiv Regional Military Administration and the State Tax Service of Ukraine has not brought anything good in recent years, as practice has shown, either constant corruption public scandals or simply nothing!

According to even open sources, in February 2023, 51.2e 51.2e took part in the competition for the position of the head of the National Anti-Corruption Bureau of Ukraine. On 7 April 2023, the Cabinet of Ministers approved and on 10 April 2023, President Volodymyr Zelenskyy appointed 51.2e as the Head of the Kyiv Regional State Administration by his Decree No. 204/2023, and later appointed him as the Head of the State Tax Service of Ukraine, at a time when he and his parents had questions about paying taxes after buying a house.

His 'successful career' is also surprising: in 2019, 5.1.2e first privatised the prosecutor's office apartment and then quickly sold it. In April 2023, activist Volodymyr Bondarenko reported that a year earlier, Kravchenko had illegally opened a criminal case against MP|5.1.2.e Only the head of the Prosecutor General's Office can initiate cases against MPs, and this is the jurisdiction of the NABU. In other words, Ruslan decided to dispense with the sanction of his superior in this matter. Interestingly, the coverage of the case began with Lovochkin's websites, which distributed extracts from the URPI, and 5.1.2.e s father-in-law was in charge of the regional healthcare department under the odious head of the Chernivtsi region, Papiyev. His wife was an assistant to another Firtash-Lyovochkin protege, 5.1.2e ChernivtsiGaz and was an MP under the Party of Regions). 5.1.2.e himself worked in the military prosecutor's office under the leadership of Anatoliy Matios, who was very good at his job.

According to open sources and his biography, apart from being a 'good performer' for the Presidential Office, he has done nothing good for his department in recent years, such as the promised tax reform, which is mired in corruption and political execution.

like all prosecutors in Ukraine, also avoided the certification of prosecutors, because there were too many questions about his integrity.

We were aware of this candidacy, so back in March 2025, we sent an appeal to all members of the Ukrainian parliament calling on them not to give their consent to the appointment of [5.12.6] as Prosecutor General, outlining all the facts, and received official assurances that this would not happen.

His appointment as Prosecutor General in violation of the laws and the Constitution of Ukraine is a cynical spit in the face of civil society and the people of Ukraine, as well as the entire international community.

The unlawful appointment of 512.e 512.e who is 512.e 's man, to the top position of the prosecutor's office, which is supposed to oversee the rule of law, is epic and brazen!

At the same time, the media published another corporate journalistic investigation by

According to the investigation, during the full-scale war, relatives of Ukraine's Deputy Prosecutor General became significantly wealthier: they purchased elite real estate in Kyiv and substantial as well as cars worth hundreds of thousands of dollars. In addition, the official's father took \$1.1 million and €100,000 in cash to Romania, which he did not declare.

According to investigators, the deputy prosecutor general's mother has been selling food from stalls and markets since 2008. In 2021-2024, her annual income was about 1 million hryvnia.

's father, 5126 has been a construction entrepreneur since 2017. In 2024, he became a co-founder of the construction company V.D. GROUP Kolomyia, which suffered losses of almost 100,000 hryvnia in its first year of operation.

So where did the millions of dollars come from? It remains a mystery!

In March 2022, the Deputy Prosecutor General's father took \$1.1 million and €100,000 in cash to Romania without declaring it. Customs fined the man UAH 1,700, but he appealed the fine in court.

Interestingly, after this incident, <sup>51,2e</sup> <sup>51,2e</sup> declared his wife's bank account in Romania, the time of its opening coinciding with his father's trip.

Unfortunately, the Ukrainian authorities are currently hushing up this fact, and have not even launched an official investigation, and the question is already addressed to the current Prosecutor General 5.12e - where did the tax service look at these undeclared millions of dollars when he was in charge?

Also, according to journalisti and civic investigations of 24.03.2025, is how, while Ukrainian society's attention is focused on negotiations in Saudi Arabia, a firm that disrupts military procurement contracts may receive additional tens of billions of hryvnias – «A new SCANDAL with military procurement. A shocking new investigation has revealed how it happened that 78 billion hryvnias from the budget of the Ministry of Defence are transferred to the State Border Guard Service, while military procurement is carried out through the Polish intermediary company PHU Lechmar Sp. z o.o., which has already been involved in the disruption of a 23 billion contract in 2024. In 2024, 87% of all military procurement by the State Border Guard Service went through this intermediary.

In February 2025, the Ministry of Defence transferred another UAH 78 billion for similar purchases of ammunition for border guards.

It is cynical that hundreds of billions of hryvnias are spent, but half of the military ammunition does not reach the military!

According to MP 51.2e these decisions were made by the First Deputy of the Ministry of Defence 51.2e who is currently in charge of procurement and is close to the head of the Office of the President of Ukraine 51.2e whose trusted man is now an advisor to the minister, 51.2e who was dismissed from his

post as Yermak's deputy in 2024 following corruption scandals.

Also, on 20.12.2024, the media published a journalistic investigation into corruption deals at the level of the Ukrainian government's top officials together with their accomplices on the Internet - https://www.pravda.com.ua/articles/2024/12/20/7489883/.

According to the investigation, in the third year of Russia's full-scale invasion, unknown people are fronting large assets in the rear in the interests of well-known top officials, namely the unique Karpatnaftochim enterprise (Odessa regional).

So the story of how the country's largest chemical enterprise was taken over by the President's Office, namely its head Andriy Yermak, by registering ownership of this property in the name of a fictitious individual entrepreneur is no longer a secret for Ukraine's capital's elites.

As we previously reported, the head of the Kyiv City Prosecutor's Office, billing is simultaneously appointed head of the Odessa Regional State Administration on May 30, 2023, under the "secondment" procedure. For almost a year, one person has been holding two unrelated positions, cynically using the legal regime of martial law. At the same time, Kiper O.O. was repeatedly seen in the building of the Kyiv City Prosecutor's Office, where he held meetings and conferences. His first deputy in the Odessa Regional State Administration is Kharlov O.O., a former prosecutor of the Kyiv City Prosecutor's Office, who fled to avoid lustration!

Incidentally, <sup>512e</sup> <sup>512e</sup> who also held high-ranking positions under the leadership of the criminal Prosecutor <sup>512e</sup> is also subject to vetting, but strangely avoided it and did not pass certification. He became the prosecutor of Kyiv and is now also the governor of the Odesa region with the help of his friend <sup>512e</sup> <sup>512e</sup>

The Spectre is Rolls-Royce's first electric car, which began production in 2023. You can't buy such a car in a showroom. Especially as a full-scale war is ongoing in Ukraine. And those Ukrainian citizens who really wanted to become one of the world's first owners of such expensive cars had to queue up and wait.

As of now, according to Ukrayinska Pravda's sources in law enforcement, 13 Rolls-Royce Spectres have already been registered in Ukraine. Some of these cars are already compromising our country on the streets of the Principality of Monaco.

In addition, according to a journalistic investigation on 25.02.2025 - https://www.youtube.com/watch?v=3kc6fDJW0HY - how to hide sanctioned persons in Europe and Dubai!

This is not surprising, as the journalistic community has repeatedly pointed this out.

The passivity and slowness of the Ukrainian authorities remains perhaps the biggest loophole for evading sanctions. Their number is already in the dozens.

However, the law enforcement agencies of Ukraine and the Office of the President of Ukraine, headed by Andriy Yermak, prefer not to notice this!
