Dear Sir,

My name is 5.1.2.e (5.1.2.e). I'm a Rohingya Refugee in Bangladesh. I'm feeling different kind of tortures from April, 2019 to up now in this country. I have already contacting and sharing my troubles to the UNHCR in Bangladesh of the Country Representative, Senior Officers, the Protection Unit and Camp Focals for help from July 29/2021 to up now, but they were completed to me and 5.1.2.e at durable solutions assessment(DSA) to resettle to the third country. And then, they were confirmed to my 5.1.2.e 5.1.2.e 5.1.2.e families as the resettlement to the Ireland. And also, they are refusing to me to it. They said to me that they are afraid of Bangladesh Government. But, i don't know, why they are refusing to it because i have not done anything against Bangladesh Government and their Authorities. They(UNHCR in Bangladesh) are also suggesting to me that i can find to contact other international resettlement agencies or sponsor groups.

I'm seriously feeling some diseases, including gastric ulcer, nose pain and shoulder pain. I have no way to go to the Rohingya Refugee Camp in Bangladesh where my wife and sons are living. If i go there, the ARSA(Arakan Rohingya Salvation Army) and their supporters will kill to me suddenly. And i'm staying the unsafe place outside of Rohingya Refugee Camp in Bangladesh. And there, the local communities(Bengalis) are regularly doing day by day of kidnaps, robbers, murders and etc. I'm also feeling different kinds of threats from the local communities, the ARSA and their supporters. And i don't know, what's time, i will be kidnap or kill. I'm living the highest level of risks about my life. I urgently need your help. Please save my life from this hell and try to get me as the resettlement or asylum to the third country as soon as possible.

Dear Sir/Madam,

My name is 5.1.2.e (5.1.2.e). I was graduated M.A(English) in Yangon University, Myanmar from 2015. Since September 2017, i have been living in Bangladesh Rohingya Refugee Camp (14) and ARSA(Arakan Rohingya Salvation Army) terrorists were tried to join their groups. But i was refused to enter their groups and they were extremely tortured to me four times. Unable to bear the tortures, my father, 5.1.2.e died of a sudden heart attack on July 26/2021. And then, i was complained at the Camp In Charge (CIC), Bangladesh Police and other authorities, but they were not taken any action against ARSA and their supporters. And also, on February 5/2024, my mother also died suddenly, crying for me because i'm feeling in troubles and she didn't meet to me.

From July 29/2021 to up now, i have not been able to stay with my family(wife and sons) in the Rohingya Refugee Camp in Bangladesh. I'm seriously feeling some diseases, including gastric ulcer, nose pain and shoulder pain. I have no way to go to the Rohingya Refugee Camp in Bangladesh where my wife and sons are living. If i go there, the ARSA(Arakan Rohingya Salvation Army) and their supporters will kill to me suddenly. And i'm staying the unsafe place outside of Rohingya Refugee Camp in Bangladesh. And there, the local communities(Bengalis) are regularly doing day by day of kidnaps, robbers, murders and etc. I'm also feeling different kinds of threats from the local communities, the ARSA and their supporters. And i don't know, what's time, i will be kidnap or kill. I have no way to return to the Myanmar(Burma) because there are ongoing civil war between Myanmar's Military Council and Arakan Army(AA). There is no safe place for Rohingya minorities in Rakhine State, Myanmar. I'm requesting as the asylum or resettlement to the third country because i don't feel to continue this troubles in Bangladesh. I'm also living the highest level of risks about my life. I urgently need your help. Please try to save my life as soon as possible.
